9	Page 9, District Offices, fifth bullet; Page 14, Conduct Preparation and Analysis, last sentence in first paragraph; Page 17, Metropolitan Planning Organizations bullet: Added wording provides for FDOT analysis of the alignment between existing MPO LRTPs and the FTP. Suggest making this analysis a collaborative effort with the MPOs consistent with the requirement in ss. 339.175(7)(a) that MPO LRTPs consider the goals and objectives identified in the FTP as well as give emphasis to those transportation facilities that serve national, statewide, or regional functions (see also 23 USC 134(i)(2)(A)(i) and 49 USC 5303(i)(2)(A)(i) regarding facility emphasis). Will this analysis recognize the iterative and sequential nature of long range transportation plan updates led by FDOT and led by MPOs in a changing environment? Will a compilation and comparison of performance metrics used be part of the analysis?	The reference to reviewing MPO LRTPs is only meant to ensure that the FDOT District offices are in close contact and communication with the applicable MPO's regarding the update of the FTP.
